Continued Support for Striking Workers at Woodland Pulp LLC

Members of IAM Local 1490, SEIU Local 330-3, and Millwrights Local 1121 have been on strike for over a month in Baileyville. The Company has been unwilling to budge on its proposed language that would turn all of the skilled trade workers into general mechanics. The workers are adamantly opposed to such language.

We've sent representatives to their picket line three times and passed a motion to send \$1000 to each local to help assist the strikers in their time of need. We are doing all we can to stand in solidarity with our Brothers and Sisters in Baileyville.

A federal mediator was brought in last week, but after two days of negotiations the Company still did not move on its position and the Negotiating Committee returned to the picket line. This last Wednesday we returned to their picket line as they resumed negotiations. They are grateful for the camaraderie and morale boost that comes along with our presence.

The time we spent on the picket line last Wednesday was very eventful. Police showed up in force, but we were able to speak with them to explain how our picketing activities are legally protected. We focused our efforts on slowing the flow of tractor trailer-trucks coming in and out of the facility. The frustrated truckers got more aggressive as the day went on. They became more willing to speed toward the picket line in an attempt to scare away the workers. We held the line and, on two occasions, dealt with truckers leaping out of their cabs to brandish pry bars at us. No one was injured, but one trucker was issued a criminal offense summons for driving to endanger.

Luckily, the Maine legislature recently passed a law that allows striking workers to collect unemployment if their employers hire scabs. This is great news for all workers, especially the Baileyville pulp workers who have been on strike for over a month. We hope Company management will come to their senses and offer these workers a fair contract. The fight will continue until their demands are met. As long as the pulp workers are on the line, Local S6 will be too.
