Baileyville Workers Ratify Contract, Ending Strike

After 6 weeks of being out on strike, the members of IAM Local 1490, Millwrights Local 1121, and SEIU Local 330-3 have ratified a collective bargaining agreement with Woodland Pulp. The company came back to the table with union proposed language just a day after the Baileyville Police and Washington County Sheriff's department came to the picket line and arrested 1 member of Local 1490 and 3 members of Local S6. We maintain that these arrests were wrongful and believe the charges will be overturned. Our picketing members were on public land when they were arrested for criminal trespassing. We want to commend Eric Severy, Adam Bowen, and Marc Lindvall for holding the line while under the threat of arrest. While many of our members assumed the same risk, these three were arrested in an attempt to scare the rest of the picketers. Fortunately, the tactic did not work. We did not back down. Union leadership continued to explain that we were engaging in protected activity and were not in violation of the law. The picket line held and the police left the scene.

The CBA gave general wage increases of 4%, 3%, and 3% over the life of the contract, with an option for journeymen maintenance employees to be placed in a new classification to receive a 11.6% immediate wage increase. They also received an increase to their vacation time and paid sick leave. We wish our brothers and sisters well as they move forward with their new contract. It is great to see what is possible when we stand together for each other's benefit.
