## New IAM International President Brian Bryant Prioritizes Working People's Rights

Brian Bryant, a former Local S6 Pipefitter, has been inaugurated as the 15<sup>th</sup> International President of IAM. His time working for our membership with the local, district, eastern territory, and executive council has shaped his vision for the future, "It is time to not just improve the state of working people, but to fundamentally transform the way working people live. We demand not just a seat at the table, but a chance to call the shots."

In an open letter to the membership, he shared some goals for his strategy moving forward, "We are preparing to tackle the most pressing challenges facing the IAM, like sustaining our growth, membership engagement, branding our union for the future, and much more."

## Starbucks Faces NLRB Complaint Over Store Closures in Union Dispute

The National Labor Relations Board has filed a complaint against Starbucks for closing 23 stores, including the Portland, Maine location, soon after employees voted to unionize. Shareholders are pushing for a reevaluation of the company's adherence to Human Rights standards following an independent assessment revealing issues. Starbucks is returning to negotiations with 370 unionized locations that seek to ratify contracts.

## Maine AFL-CIO Convention and Proposed Per Capita Rate Increase

The Maine AFL-CIO postponed its biennial convention to January  $11^{th} - 12^{th}$  due to the tragic shooting in Lewiston. We have sent 5 representatives to vote for the next Maine AFL-CIO President, Vice President, and Executive Board and discuss a proposed per capita rate increase for member contributions. The proposal is to increase the current per capita rate of \$1.25 per member per month by 25 cents over four years to \$1.50 by 2027.

# Maine Lobstering Union Challenges Tracking Requirements

Maine Lobstering Union members are contesting a new Maine Department of Marine Resources regulation mandating electronic tracking on fishing vessels. While members support better fishery management, they express concerns about privacy infringement and information sharing with other industries. The lobstermen believe the 24/7 surveillance of their vessels is an infringement on their constitutional rights to privacy. GPS trackers would record their position once a minute while they are moving and cannot be shut off so long as their boats are in the water. The Local 207 members are happy to assist fisheries management with meeting those goals, but would like to do so without their personal privacy being impacted and without risk of their information being disseminated to benefit other offshore industries.
